

ETHICAL BUSINESS POLICY STATEMENT

1 INTRODUCTION

Seagems Group and its subsidiaries (hereafter "Seagems") are committed to the highest standards of business ethics which govern the conduct of our business operations and our employees.

2 PURPOSE

We expect all our stakeholders, including employees, vendors and suppliers, business partners, shareholders, and investors, to be aligned in upholding a high ethical standard.

4 CUSTOMERS

Seagems will take all reasonable care to avoid misleading statements, concealment, and overstatement in all our advertising and public statements. Seagems will seek to build long-term partnerships with our customers by always being honest and straightforward in our dealings. We will respect the confidentiality of any information obtained about our customers.

5 COMPETITORS

Seagems will build its reputation based on its performance alone. Seagems will not cause or be part of any breach of applicable competition laws and regulations, such as illegal cooperation on pricing, or illegal market sharing. We will act independently of our competitors and will not seek to damage the reputation of our competitors either directly or by implication.

6 MONEY LAUNDERING AND TAX OBLIGATIONS

Seagems will ensure compliance with all applicable anti-money laundering laws and shall take steps to prevent its financial transactions from being used by others to launder money. Seagems will report and pay its public taxes and fees according to the current law requirements.

Seagems shall comply with laws and regulations related to bribery, corruption, fraud, and all other illegal business activities.

Seagems will not sponsor political parties or politicians.

Seagems has zero tolerance for all forms of corruption, and we will act openly, transparently, and intelligible on this matter.
